## **DECLARATION OF JONATHAN GROSSMAN**

1. I am a Staff Attorney with the Sixth District Appellate Program, which has been appointed to represent appellant Romeo Montague. I am handling the appeal as a staff case.

2. I have drafted part of a rough draft to the opening brief, which currently has four issues. There are three more potential issues that I am planning to draft. Because drafting the brief has taken longer than I anticipated, I am requesting an extension of time to October 22, 2008.

3. Appellant's opening brief is due September 22, 2008.

4. A notice pursuant to rule 8.360(c) has not been issued.

5. There has been one previous request for an extension of time.

6. Appellant was convicted on January 4, 2008 of murder (Pen. Code, § 187, subd. (a)) with a gang enhancement (Pen. Code, § 186.22, subd. (b)), two counts of statutory rape (Pen. Code, § 261.5, subd. (a)). He was sentenced to serve 27 years to life in prison. He is not on bail pending appeal.

7. The record on appeal consists of a clerk's transcript of 440 pages (excluding the preliminary hearing transcript) and a reporter's transcript of 752 pages.

8. I therefore respectfully ask that this court grant this request for an extension of time of 30 days, to October 22, 2008, to file appellant's opening

brief.
